

GENERAL CONDITIONS OF THE “GETAWAY IN THE ARDENNES!” PROGRAMME

1-Conditions of eligibility, filing and terms of awarding:

- Applications will be submitted **exclusively** on the cd08.fr website, **within one month of the end of the stay**.
- The stay should take place **between 31 March and 31 December 2021**, **only** in the Ardennes département (FRANCE).
- **No other documents than those requested will be accepted** (e.g.: no booking or rental contracts, bank card receipts, etc.).
- **All French or foreign tourists, excluding associations** can apply. Professional stays are excluded from this programme. Ardennes residents are eligible for the programme in the same conditions.
- The benefit will be attributed to the beneficiary for all separate stays, in the form of a subsidy of 50% of eligible expenses. The amount of the benefit will be capped at €100.

To receive the département local authority benefit, the applicant must fulfil and show proof of the two following conditions:

- **a minimum of two consecutive nights** spent at an Ardennes accommodation provider (hotel, campsite, gîte, guesthouse, group accommodation or unusual accommodation), with staying in different accommodation possible,

and imperatively at least:

- a catering service in an Ardennes establishment and/or a paid-for tourist activity in the Ardennes (cultural and leisure) **imperatively** undertaken **during the stay** (dates of the accommodation).
- Establishments providing proof for the benefit must respect the regulations in force:
 - ensure that fire and hygiene standards, and Covid 19 health protocols are respected...
 - and, in particular, for gîte and guesthouse owners, show town hall registration of accommodation in a private home.

- The benefit will be paid with proof of:
- **the bill** from the accommodation in the name of the applicant,
 - **receipt(s) or bills** for catering and/or the paid-for tourist activities (cultural or leisure),
 - **proof of bank details, imperatively in the name of the applicant** (Relevé d'Identité Bancaire (French bank details slip) or proof from the banking organisation for foreign tourists showing the IBAN/BIC).

Any incomplete application will not be accepted.

For each application a receipt will be sent to the email address indicated in the form.

Any exchange by email must be done **exclusively** via the email address given in the form. The name of the benefit applicant should be given in all correspondence.

2-Personal data:

The collection and processing of your data (first name, last name, postal address, email address, bank details and telephone number requested in this form) are required for this support to be given.

The benefit beneficiary undertakes to take note of these general terms and conditions and accept them with no reservations.

The data may be used by the département local authority for anonymous statistics of the programme.

After the beneficiary has given their agreement, the email addresses collected may be used by the Ardennes département local authority to send information or news about the programme and by the Ardennes Tourist Development Agency with the aim of tourist promotion.
